What Drives HathiTrust Program Priorities?

Historically:

- 2008-2010: HathiTrust Functional Objectives (13)
 - Public 'Discovery' Interface for HathiTrust, Full-text search, Page turner
 - APIs for member institutions' use and integration of data
 - TRAC Certification, more...
- 2011-date: *Constitutional Convention Ballot Initiatives* (5)
 - Expand and enhance access to U.S. federal publications
 - Establish a distributed print monograph archiving program
 - Formalize a transparent process for development initiatives
- 2014-date: *Strategic Issue Briefs* (4)
 - Non-Text Formats
 - Quality Assurance and Validation
 - Services for Print Disabilities
 - Metadata Strategies and Policies



How Does the PSC Get Work Done?

1. Through close orchestration with the Board of Governors and the Executive Director; and

2. A process of:

- Discerning needs and interests of the membership,
- Scoping strategy and work agendas, and
- Assembling key experts from the membership to serve on committees and working groups to advance exploration and/or instigation (with PSC liaison/lead structure)

HathiTrust PSC Committees and Working Groups

- **Collections Committee** (2014, July 2016): A standing committee responsible for collection development activities and policies, charged with making key recommendations about HathiTrust content.
- Metadata Policy, Strategy, Use and Sharing Advisory Group: (2015) MUSAG is charged with reviewing managed metadata, formatting relevant policy and strategic directions to benefit the members. Interacts closely with the Zephir Advisory Group.
- **Quality Assurance and Standards Working Group** (August 2016): Recommends strategies, processes, and techniques detailing how members, end users, and/or HathiTrust Operations can assure the quality of the HathiTrust corpus.
- **Rights and Access Working Group** (2014): Promotes HathiTrust's ability to provide the widest possible access to its collections within the law by establishing priorities for rights determinations and strategies for engagement with rights holders.
- Ad Hoc Development Framework Working Group (2015): Responding to passed Ballot Measure #2, creates a transparent and well-managed process for HathiTrust development initiatives that follow overall programmatic decisions.

HathiTrust Program Initiatives with PSC Advisory


- Federal Documents Advisory Committee (August 2016): makes recommendations regarding implementation of the U.S. Federal Documents Program.
